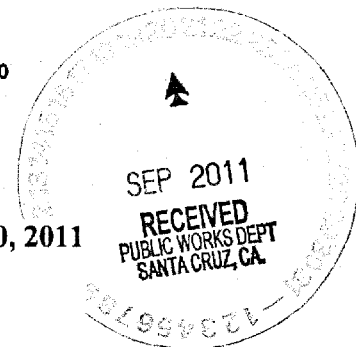

Members of the Board:

The subject project was completed on July 11, 2011. The contractor was Monterey Peninsula Engineering, Inc., of Marina, California. The project consisted of the abandonment of existing and construction of new force mains from two existing pump stations to the existing treatment plant. Work included installation of valves, electrical conduit, utility boxes, air release valve, and connection to the existing facilities within portions of the County Service Area treatment plant site.

The original bid price was \$178,286.70, and total construction cost is \$178,283.97. A summary of final costs is attached for your information.

It is therefore recommended that the Board of Supervisors take the following actions:

1. Accept the improvements and approve the final cost of \$178,283.97.
2. Authorize the Clerk of the Board to file the Notice of Completion, a copy of which is attached.

- Direct the County Recorder to return the original Notice of Completion to the Clerk of the Board.


